



Terms and Conditions Governing the GOtv Mozambique Reconnect and Stay Promotion

1. Preamble

- 1.1. These Terms and Conditions (*"the Terms and Conditions"*) shall apply to the **GOtv Mozambique** Reconnect and Stay Promotion (*"the Promotion"*) and a person participating in the Promotion is deemed to have read, understood and accepted these Terms and Conditions.
- 1.2. We always offer our subscribers value by making great entertainment accessible to them. In this Promotion, we provide eligible GOtv subscribers with an opportunity to reconnect and stay connected to the service.

2. Promotion Period

The Promotion will run from 0000 hours on **20 November 2023** (*"Commencement Date"*) to 2359 hours on **10 December 2023** (*"Promotion Period"*).

3. Eligibility and Participation

- 3.1. During the Promotion Period you must:
 - 3.1.1. be an active or new GOtv Lite or Essential subscribers (*"eligible subscriber"*) in Mozambique;
- 3.2. The Promotion is not open to -
 - 3.2.1. subscribers who are already enjoying any of the other GOtv offers;
 - 3.2.2. directors, members, partners, agents, employees or consultants of the MultiChoice Group of companies or any supplier of goods or services in connection with the promotion; and
 - 3.2.3. the spouse, life partner, business partner or associate, or the natural or adopted parent, child, or sibling, of any of the persons specified in 03.3.2. above.

4. The Promotion

- 4.1. Upon becoming a GOtv Lite subscriber, you will automatically be granted access to the GOtv Essential bouquet until the end of the Promotion Period. At the end of the Promotion Period or the end of the period for which you have paid for GOtv Lite (whichever occurs first) your access to GOtv Essential will be disabled, unless you make payment for a GOtv Essential bouquet.
- 4.2. Upon becoming a GOtv Essential, you will automatically be granted access to the GOtv Plus bouquet until the end of the Promotion Period. At the end of the Promotion Period or

the end of the period for which you have paid for GOtv Essential (whichever occurs first) your access to GOtv Plus will be disabled, unless you make payment for a GOtv Plus bouquet.

- 4.3. For eligible subscribers in clause 3, we will grant you access within 48 hours of our receiving your subscription fees.
- 4.4. This Promotion is not available in conjunction with any other promotions we may be running.

5. How to Participate

- 5.1. To enjoy the Promotion, eligible Subscribers are required to connect, reconnect or remain connected to the service by paying for the GOtv Lite or Essential subscription fees as explained in clause 4.
- 5.2. Subscription is not transferable and may not be deferred beyond the period for which the subscription has been paid;
- 5.3. It is the Subscriber's responsibility to ensure that the Subscriber's payment is received by GOtv within the Promotion Period.
- 5.4. To continue enjoying the service after the Promotion Period, the Subscriber will need to pay subscription fees as and when it falls due for the then current bouquet or any other bouquet at the rates published by GOtv.

In any of these events, notice will be given via media advertisements or in any other such manner as GOtv may at its discretion choose and such notice will be effective immediately or as at the date referred to in such notification.

In the event of such amendment, variation, postponement, withdrawal, suspension or cancellation, the subscriber agrees to waive any rights, interests and expectations that the subscriber may have in terms of this Promotion and acknowledges that the subscriber will have no recourse against GOtv or its affiliates in any way or at all.

- 6.4. Without limitation, we and our affiliates are not responsible for any issues encountered with third party merchants.
